


Country Support Hub

Frequently Asked Questions

1) What is the Country Support Hub?

The Country Support Hub (CSH) launched in 2016 as a mechanism through which NAP Global Network participants in developing countries can receive free expert advice and/or short-term targeted technical support that will help maintain momentum in their NAP process, whether in the development or implementation phase.



2) What types of support can my country request through the CSH?

The CSH specifically focuses on short-term support. The length of the projects supported tend to be under six months and can serve to fill gaps in the NAP process.

Some examples of the types of requests your country can make through the CSH include:

IMPLEMENTATION

- » Developing a financing strategy for NAP implementation.
- » Structuring public-private partnerships for adaptation projects.
- » Support in designing domestic fiscal instruments to support implementation of prioritized adaptation actions.

PLANNING

- » Developing an outreach and stakeholder engagement process.
- » Developing a communications strategy to support the NAP process.

MONITORING & EVALUATION

- » Developing M&E indicators.

INSTITUTIONAL ARRANGEMENTS

- » Conducting an institutional context analysis.

INFORMATION SHARING

- » Facilitating dialogue between actors at national and sub-national levels to help encourage vertical integration.

CAPACITY DEVELOPMENT

- » Advice on mainstreaming gender in the NAP process.
- » Advice on ensuring the NAP process is inclusive of Indigenous groups

3) How do I submit a request to the CSH?

4) Who can make a request?

You must be working for a developing country government (in any agency and at any level) that is involved in the NAP process or its implementation.

While you should ensure your NAP focal point is aware of requests that are being made, he/she is not the only person who can submit requests.

5) Are there any requirements prior to making a request?

Just one: You must be registered as a NAP Global Network participant to submit a request (if you haven't already registered, you can easily do so [online for free](#)).

6) How many requests can a country make?

At any given time, the Network can address up to two requests per country from different ministries/agencies involved in the NAP process. If you want to submit more than one request, please fill out a different form for each request.

7) How long does it take for a request to be processed?

The Network Secretariat will review your request and acknowledge receipt within three business days, including an estimated timeline for providing a full response to your request and a description of the type of support that we can offer.

Response times may vary depending on the nature of your request and volume of requests received, but we aim for a turn-around time of two weeks.

8) How will the NAP Global Network assess my request and determine eligibility for support?

The Network will assess your request and determine if and how we can provide support based on the answers you provide in the request form to the following two criteria:

- a)** Justification and relevance to the NAP process: Clear indication of how the assistance provided will fill a gap to support the NAP process and/or implementation in the country.
- b)** Targeted and complementary scope of support: Clear definition of the gap the support would fill and the time frame within which you envision it taking place, particularly in relation to longer-term support being provided by other donors in the country. Given the targeted and complementary nature of the support the Network provides, the scope of the support requested must be achievable within up to approximately six months. Complementarity with other support may be verified by the Network Secretariat in consultation with in-country donors, as needed.

9) How does the NAP Global Network respond to CSH requests?

Depending on the nature of your request, the Network may respond to your request in one of the following ways:

- a) Expert advice** from a member of the Network Secretariat or our growing roster of experts from around the world in response to questions about the NAP process and its implementation. This advice would be provided virtually, from a distance.
- b) Targeted in-country technical support** that addresses a specific, short-term gap inhibiting momentum in the NAP process or its implementation, and that complements broader support for adaptation that may be available through bilateral or other programs.
- c)** Support for convening and facilitating meetings with key stakeholders to advance or build support



for the NAP process and its implementation. For example, this could include a kick-off meeting, a technical workshop on a specific topic, or the launch of a NAP document and discussion on how to move forward with implementation.

10) Can the CSH provide support with Nationally Determined Contributions (NDCs)?

Yes. Targeted technical support can be offered to ensure linkages and alignment with other national planning and policy processes, including NDCs.

This might include, for example, help with preparing or revising the adaptation component of an NDC, helping translate adaptation contributions in an NDC into activities or outputs, helping to ensure climate risk is taken into account in a country's plan to pursue Sustainable Development Goals (SDGs), or helping identify links with disaster risk reduction.

11) Can the CSH provide support with Green Climate Fund (GCF) requests?

Yes. Targeted technical support can be offered to strengthen GCF proposals by providing an analysis of particular components such as gender mainstreaming, which is one of the GCF review criteria.
